4. Shipping.		

- First collection included in stud fee, subsequent collections \$300.00 cnd + 5% gst.
- Breeding contract and fees must be paid in full prior to the semen being shipped. □ Disposable shipping containers DO NOT need to be returned they are included. □ I need to be notified of the first day of your mare's heat, so that we can plan the collection/shipment. Collection request forms must be received, please contact for that form.
- We must be notified by telephone by 12:00 noon CST the day before the semen is to be shipped.
- All unused semen must be destroyed and under no circumstances may any other mare, which is not in the contract, be inseminated.
- We will ship the semen on the designated day via prearranged transport and notify you or your vet with the details of the shipment and arrival time.
- We ship Monday-Friday
- We primarily ship Fed-Ex that can be paid on your credit card or charged to your account.
- Air Canada OR West Jet will be shipped collect. Transport of shipment to airport, is \$175.00.

## 5. Conditions

• Should the semen not arrive in viable condition at the time of delivery, the stallion owner will bear the cost of transportation for the next shipment unless the semen is lost or delayed due to the negligence/difficulties of the courier, in which case we will try to get a refund from the courier.

- The mare owner should assume all responsibly for the condition of the mare and bear all the risk of loss or injury for the mare.
- Any vet costs related to the said mare are the mare owners responsibility.
- Should the mare die or become unfit for breeding, then a different mare may be substituted with approval form the stallion owner.
- This stallion breeding contract is not transferable by the mare owner to another party without the prior written consent of the stallion owner.

## 6. Live Foal Guarantee

- The LFG is based upon full and complete adherence to this contract
- Should the said mare fail to produce a live foal due to death of the foal, abortion, or failure to conceive (as determined by a veterinarian pregnancy check) the stallion owner requires a written statement from the mare owner's vet within one week of the occurrence.
- Upon failure to produce a live foal, the mare owner is entitled to a rebreed the year following the initial breeding. The mare owner then agrees to pay the booking fee of \$150.00 + \$300.00 collection fee per cycle (+ 5% gst).
- Should the said mare fail to produce a live foal after 2 yrs the stallion owner can request another mare.
- If the mare fails to produce a live foal and the stallion dies or becomes unfit for service, the mare owner may choose another stallion from Boulder Ridge Ranch OR 2 doses of frozen (if available)

7. This breeding contract is valid for 2017. If this contract had not been used during this time period it becomes null & void.
