Dear Sarah:

Congratulations on your 2017 Werbellin filly. Please find the enclosed receipt, registration application, DNA kit and foal microchip. Just **pull the foal's hair sample and forward the DNA kit on to the lab as instructed.**

Please return the following to the AHS office:

- ✓ 1. **The microchip certificate.** The microchip must be implanted by a licensed veterinarian. Upon implantation, the veterinarian must complete and sign the enclosed microchip implantation certificate. **It is the foal owner's responsibility to return the completed certificate to the AHS Office.** Foal papers will not be issued without receipt of this document.
- ✓ 2. **The completed registration application** (both sides including all markings and written descriptions). The markings page must be either mailed to our office or scanned and e-mailed.
- ✓ 3. A minimum of **four color photos** showing front, back, and both sides of the horse. An example of how the photos should be taken is enclosed. We accept digital photos, so you are welcome to e-mail them to ahsoffice@aol.com or you may mail hard copies of the photos to our office if you prefer. Photos should be taken outdoors to ensure adequate lighting. All four legs should be seen down to the hoof. Please be sure to **label the back of each photo if mailing the photos to the office** (ex. 2017 Walesca filly).
4. Please note that if we receive your completed paperwork **prior to December 31, 2017**, your foal will be eligible for a complimentary USEF number which will be listed on the bottom right-hand corner of their AHS registration papers.

We have your foal enrolled at the Spruce Glen Farm inspection site. Enclosed is a stabling form for you to e-mail Sandy Hunt if you have not already so a space will be reserved for your foal. Don't hesitate to contact our office if you have any questions. We are always glad to help. Best of luck with your foal and we look forward to seeing you at Spruce Glen Farm!
