Should the foal not stand and nurse, the mare owner agrees to notify the stallion owner within one week of the foaling date and furnish a statement from a licensed veterinarian. The mare owner will be entitled to return the same mare for a re-breed provided the stallion is living and fit for service. If the stallion dies or becomes unfit then this contract shall become null and void.

A "Breeding Certificate" will be issued for the foal conceived from this mating provided all fees and other expenses have been paid in full and when the mare has produced a live foal. The mare owner assumes all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, injury or infection or any reason whatsoever and agrees to hold the stallion owner/manager harmless for any and all damages there with. This Contract is Non-Assignable and Non-Transferable without prior written consent of the stallion owner.

This contract is entered into in the State of Virginia and will be interpreted and enforced under the laws of that state. This Contract represents the entire agreement between parties.
