RULES OF ELIGIBILITY

- For Half-Welsh: Sire or Dam must be purebred and registered as such in the Welsh Pony and Cob Society of America, Inc. or Section A, B, C or D of the Welsh Pony and Cob Society. For Partbred: Sire or Dam must be half-Welsh and registered as such in the Welsh Pony and Cob Society of America, Inc. or the Welsh Pony and Cob Society.
- All applications must bear the signature of owner or authorized agent of record.
- If the sire is a registered purebred or half-Welsh, the Station Service Report and annual \$15.00 filing fee from owner of stallion must be on file at the Society's headquarters no later than December 31st of the year of service BEFORE THE RESULTING FOAL CAN BE REGISTERED.
- If the dam is a registered purebred or half-Welsh, the dam's hair sample or DNA typing must be on file prior to foal being registered.
- Upon submission of the first service report for a stallion, an additional registration fee of \$75.00 and DNA typing will be required. If a stallion for which the additional fee has been paid is gelded within 30 months after the first reported service, \$50.00 will be refunded upon receipt of completed castration report and certificate of registration by the Society headquarters.
- On the vote of a majority of the Directors present at a regularly called Board of Directors meeting, DNA testing can be required as a condition of registration or continued ownership papers.
