PRODUCT NOTES

¹Banamine (flunixin) is an NSAID primarily used to treat pain and discomfort in horses, especially colic.

Banamine is contraindicated in horses with a known hypersensitivity to the drug. It should be used with caution in those that have pre-existing GI ulcers, kidney and liver disease or a blood disease. Adverse effects include rare anaphylaxis (allergic reaction), especially when given intravenously. There may be pain and swelling if injected into the muscle, and potential life threatening infections may occur with injection into the muscle. More then one NSAID should NOT be used concurrently.

PenMar Equine recommends Banamine be given orally (paste or injectable) or by intravenous injection. DO NOT GIVE in the muscle.

2 It is very important to give antibiotics as directed by the veterinarian. Not finishing all of the antibiotics prescribed to your pet can result in an infection coming back that never truly went away and bacteria that are now resistant to the drug initially prescribed. Please give all the antibiotics until gone, unless directed otherwise.

Case Summary: Roxee presented today for a prepurchase examination. She has been owned by the current owner, Fonda Rowe, for five years. Roxee has been ridden as a trail and hunter pony. Over the last month she has been lightly ridden. Debbie is looking to use Roxee as a trail horse and for some schooling shows.

Roxee has a current negative coggins test. Pen Mar Equine has been her routine veterinarian and had the following vaccines provided in the spring; Core Innovator. She has not been vaccinated for PHF. Her feet were last trimmed on 6/7/19. She is currently barefoot. Roxee had a dental completed approximately 12 months ago. She has been fed one quart of Mane Menu daily along with free choice hay. She is kept in a dry lot and not on much pasture. Her biggest vice according to her current owner is not being able to easily administering paste in her mouth, but she has no trouble taking the bit.

Physical Examination: On presentation, Roxee was quiet, alert and responsive. During her physical examination her vital signs were normal with body temperature 98.9F, heart rate 32 bpm, respiratory rate 10bpm, normal gastrointestinal sounds, and normal mucous membranes. She had a body condition score of 5/9, a B+ for muscling over the topline, and was 930# on weight tape. She is approximately 14.1 hands tall. She has good fill in both jugular veins and there is no sign of a surgery scar on her abdomen.

Opthalmic exam revealed a normal lens and retina in both eyes. Fluoroscein stain negative. She has pink skin in areas around her left eye. There is currently no sign of SCC.

Dental exam revealed good occlusal surface with moderate enamel points on upper and lower arcades.

Roxee was negative to hooftester on all four feet. Acupuncture points over back were normal. Range of motion of joints was good. All tendons and ligaments of lower limbs were normal to palpation.

Nervous Examination: Cranial nerves are intact. She flexed his neck normally to the left and right without discomfort. She placed her feet normally in circles and while backing.

Lameness Examination: While examining in hand she was symmetrical at the walk. She was baseline grade 0.5/5 on the right hind in a straight line trot in the ring. She paddles moderately with both front limbs, R>L. Front limbs did not resist flexion.

Upper hind limb flexion of right was Grade 1/5 and Stifle extension of left hind was Grade 0.5/5. Lumbosacral and Sacroiliac areas flexed normally. All other hind limb flexions were normal.

Radiographic Examination: No radiographs were taken at this time.

Comments: Roxee had excellent ground manners and behaved in hand when being trotted during PPE. She should be kept in a UV protective fly mask year round for protection of the pink skin by her left eye. She has a healthy mouth, but is due to have her teeth floated. She is up to date on vaccines, but will need to be given a series of PHF vaccines as she has not been previously vaccinated for PHF. She flexed well overall, but is slightly lame on her right hind leg. To diagnose where the problem is coming from, I would recommend a full lameness exam, potentially with radiographs. The degree of lameness shown today is very minor and should not affect the level of work you wish to do with her. She may benefit from periodic chirappractic work. Overall, she appears to be a very
